## **SCAMMERS**

The holiday shopping season is just around the corner. While you're busy hanging lights and tossing tinsel, scammers are looking for ways to catch you off guard. Watching for common scams can help keep you and your money safe and put scammers on the naughty list.

#### **IRS Impostor Scam**

The real IRS won't ask you to pay with prepaid debit cards or wire transfers. They also won't ask for a credit card over the phone. And when the IRS first contacts you about unpaid taxes, they do it by mail, not by phone. Don't wire money or pay with a prepaid debit card. Once you send it, the money is gone. If you have tax questions, go to **irs.gov** or call the IRS at **(800)** 829-1040.

#### Phony charity donation requests

Recorded sales calls are illegal unless you give a business written permission to robocall you. If your number is on the Do Not Call Registry, you're not supposed to get any sales calls — live or recorded. But scammers ignore the rules about when and how they can call you.

Scammers can use technology to make their calls look like they come from anywhere: the IRS, a business you know, a neighbor, or even your own number. Because phone numbers can be faked, you can't trust your caller ID. So now what?

Hang up. Don't press a number. Just hang up the phone on unwanted calls. Consider callblocking services to reduce the number of unwanted calls you get. Ask your phone carrier about call blocking and read expert reviews about your options. Learn more at **ftc.gov/calls**.

### **BOARD ELECTION**

The Board-appointed Nominating Committee has provided the Board Secretary with its list of Board and Supervisory Committee candidates. Nominations may also be made by PHCU members by means of petition containing the signatures of at least 50 members. To be valid, nominations by petition must be submitted with brief biographical data of the candidate and a signed certificate from the nominee stating that he/she is agreeable to the nomination and will serve if elected to office. Nomination forms may be obtained at any PHCU branch location, or by calling **(803) 978-2101** option 5.

The deadline for submitting nominations by petition to the Credit Union's corporate office is Friday, November 5, 2021. Please note, nominations will not be taken from the floor at the annual meeting.

The election will be by means of a mail or email ballot. Ballots will be sent to PHCU members only if there are more candidates nominated than vacant seats on the Board or Supervisory Committee.
